#### 1. When was Novartis founded?

Novartis was founded in December 1996 by the merger of two successful international Swiss-owned companies with complementary product lines – Ciba-Geigy Ltd. and Sandoz Ltd.

Novartis is one of the world's leading healthcare companies. We are committed to improving the well-being of people by creating products in the areas of pharmaceuticals and generics.

#### 2. What does the name Novartis mean?

Novartis comes from the Latin term "novae artes", which means "new arts" or "new skills". In essence, Novartis means utilizing scientific research, imagination, and new technologies to provide ever-greater benefits for humankind.

## 3. What does the Novartis Group invest annually in global R&D?

Our annual sales are approximately USD 41.5 billion and our investment in research and development last year was over USD 7.2 billion.

## 5. Is Novartis a global enterprise?

Yes. Headquartered in Basel, Switzerland, the Novartis Group operates in more than 140 countries around the world.

# 6. How many employees does the Novartis Group have worldwide?

The Novartis Group employs approximately 119,000 people worldwide.
